Quotations are hereby invited by the undersigned on 20/08/2021 from the service provider of Lifts having work experience in Commercial complexes/Residential buildings/Private Offices/GoU offices etc for similar type of work, Up to 3:00 PM in the office of the MD, SIIDCUL, Dehradun. The quotation will be opened on the same day at 3:30PM by the SIIDCUL Committee. The contractor must observe following points while submitting his quotations.

1. CAMC will cover Preventive Maintenance, Unlimited Breakdown Complaints with Minor Repairs.
2. Response/Repair time after the breakdown's complaint on phone must be attended with in Maximum 4 hrs.
3. The duration of the work will be of 1 year from the date of award of work.
4. Servicing/Maintenance of Passenger Lift will be done by contractor once in month.
5. Routine Checkup of Passenger Lift will be done by contractor twice in month.
6. Routine checking of ARD system proper functioning will be done by the contractor twice in a month.
7. On site statutory compliance with respect to the safety of service personnel representing contractor, has to be adhered by contractor while providing services at SIIDCUL premises.
8. The Parts to be used for the service/repair work must be got verified by Manager (Electrical), SIIDCUL, before the use. Preventive maintenance & Health check-up plan must be authorized in advance by Manager (Electrical), SIIDCUL.
9. If applicable, Income Tax will be deducted as per rule, contractor should quote his rates specified tax.
10. The Committee reserve the right of rejection or quotation or part thereof it, without assigning any reasons.
11. Firm has to provide the certificate for servicing and experience certificate for working as per above requirement.
12. The contractor should have their service center in Dehradun.
13. Any recovery proposed by SIIDCUL Technical team shall be binding on the contractor at his own cost
14. The firm must have valid GST registration.
